10. Information Items

• Personnel Update – Director, Classified Personnel, Andrea Rivera reported:

- Rivera reported that her team is closing in on the 100 mark for number of Paraprofessional – Special Education vacancies filled this year. Rivera expects her team will hit that number in the next few days. It's an unprecedented number of positions filled and speaks volumes about the work they have done so far this year.
- Rivera reports that there will be no recruitment for the Campus Attendant position in the spring time for elementary school sites. Rivera expects most vacancies will be at the middle school sites. Rivera states that we will be seeing recruitments for all middle schools over the next few months as we receive vacancies to fill.
- Rivera reports that she has completed the analysis of the Extended School Services job descriptions in the Instruction family and that she has shared them with the Extended School Services Manager for feedback. With the Extended School Services completed, Rivera states that she will now move onto the next family, Transportation followed by Child Nutrition. Rivera is anticipating receiving the remaining job families from Rick, our consultant, as previously promised. Rivera states that she reached out to the consultant to see if they were still on target to receiving the information, but has yet to receive a response.
- District Update Assistant Superintendent, Human Resources, Dr. Meg Jacobsen reported:
 - Jacobsen states that there were many classified personnel working over Spring Break to keep the work flowing. She mentioned her gratitude for the work that

Rivera and her team are doing for the global study. Jacobsen anticipates being able to bring more job descriptions to a future bargaining session.

- Jacobsen reports that there is a lot of motion with the 6th grade transition from elementary schools to middle schools. Jacobsen also mentioned that it is Certificated staff hiring season.
- Jacobsen mentioned that she and her team have a good idea as to what the 6th grade enrollment looks like and can see the biggest growth at the Parkway Middle School Site.
- Jacobsen states that she is finished with the certificated staff transition and is now looking at the classified staff, moving staff appropriately based on enrollment and staffing needs.
- Jacobsen also notes the major work that some of our classified employees will be doing over the summer with this transition. She highlights the major projects that the warehouse and custodians will have with this transition.

• CSEA Update – Chapter 419 President, Ahmad Swinton reported:

- Swinton expressed his excitement to begin ratifying the first batch of job descriptions with members of CSEA. Swinton stated that CSEA will be having an informational meeting on April 24th. Swinton also expressed his excitement about introducing the position of Paraprofessional – Music, and going over the Instructional Media Specialist position as well as the Wellness Coach position.
