- 7. Information Items
  - Personnel Update Director, Classified Personnel, Andrea Rivera reported:
    - Rivera stated her team has a handful of recruitments underway right now, namely Supervisor, Transportation and Supervisor, Budget & Accounting. Additionally, Rivera stated that her team has the continuous recruitments, with Ali Junker, Human Resources Analyst, prioritizing filling Paraprofessional Special Education vacancies at the middle school sites. Rivera stated that she recently pulled some data for the Fiscal department regarding number of vacancies filled since returning from winter break and she noted that 31 new Paraprofessional Special Education positions that have started working between then and now. Rivera stated that that's a pretty significant number and Rivera hopes to fill a handful more vacancies before closing out this school year.
    - Rivera stated that she anticipates bringing three more job families to the steering committee the week of May 28, 2024 and bargaining the week after. Those families are Technology, Trades, and Transportation. As mentioned in previous updates, Rivera stated that she is working through receiving information from the consultant and are now down to missing 1.5 job families for the represented positions. Rivera asked to stay tuned for more information on this in the coming months as she continues to work thorough the data and bring job descriptions for approval.
    - Rivera stated that the classified employee of the year celebration is scheduled to follow the June 6th Personnel Commission meeting. Rivera

has received approximately 50 RSVPs and, although it will not account for all of the honored employees of the year and their managers, she expects to have a pretty full house.

- District Update Assistant Superintendent, Human Resources, Dr. Meg Jacobsen reported:
  - Jacobsen expressed her appreciation to Rivera and the Personnel Commission staff for their work on the classification study.
  - Jacobsen stated the she will be attending the May Revise Workshop with the California Teachers Association and California School Employees Association to talk about the governor's budget.
  - Jacobsen talked about the Retirement and Recognition Ceremony and how wonderful it was to recognize honored employees.
  - Jacobsen reported the many the district and schools are working on steps that follows the transition of six grade to middle school.
  - Jacobsen mentioned that the district was gifted with the community day schools grant of \$17 million. Jacobsen stated that the grant is to be used for community partnerships allowing access to better food, medical and dental services, and an increase in Community Liaisons who are bilingual or multilingual.
