- Personnel Update Director, Classified Personnel, Andrea Rivera reported:
 - Rivera reported that her team is making it through the craziness that has been the last few weeks with their recruitments and testing. She stated that they have received 158 applications for School Office Assistant position which is the highest number since transitioning to the computer-based testing format. She also mentioned that they haven't seen this many applicants for this classification since their 2015 recruitment.
 - Rivera mentioned that her team is seeing a similar trend in terms of an increase in other classifications as well, including custodial. One area they haven't noticed an increase of applications is in Paraprofessional – Special Education recruitment which continues to be slow-moving. Ali Junker, Human Resources Analyst, continues to manage that recruitment and handholds each candidate in hopes of filling as many vacancies as possible
 - Rivera mentioned that the California Department of Education and the office of Tony Thurmond are hosting a webinar in partnership with the California Schools Personnel Commission Association to train new or prospective personnel commissioners on their role and the history of personnel commissioners, merit system, and the like. The webinar will be on September 26th, at 1 pm. Advanced registration is required.
- District Update Assistant Superintendent, Human Resources, Dr. Meg Jacobsen reported:
 - Jacobsen expressed gratitude to Rivera and her team for their work as they go through the recruitment process for the many new recruitment openings due to grants awarded to the district, specifically the Community Schools Grant.
 - Jacobsen advised she had discussed about the challenges with recruiting for the Paraprofessional – Special Education with Rivera. Jacobsen and Rivera met with
