  - Personnel Update Director, Classified Personnel, Andrea Rivera reported:
    - Rivera stated that her team has many recruitments open. They will be very busy as they enter the holiday season. Rivera mentioned that her team encounters scheduling challenges during this time due to rater scheduling constraints. She noted that this may cause slightly longer recruitment timelines but nothing that will significantly impact the overall recruitment efforts.
    - Rivera reported that her team has filled a total of 48 Paraprofessional Special Education positions so far this year.
    - Rivera and Ali Junker, Human Resources Analyst, attended the annual Grossmont Cuyamaca Community College District (GCCCD) Career Advisory Board Meeting to network and work towards making district job opportunities more visible to community college students. The GCCCD Career Advisory Board meets annually and is managed by its career and technical education and workforce development department. This group aims to connect employers to their student population looking for work. Rivera stated that her team is new to this new networking opportunity but she believes that any strides taken towards helping advertise the district job opportunities seem beneficial to La Mesa-Spring Valley Schools.

- District Update Assistant Superintendent, Human Resources, Dr. Meg Jacobsen reported (Reported by Rivera on Jacobsen's behalf):
  - Rivera reported that at last week's board meeting, the governing board voted to authorize advanced step placing Paraprofessional – Special Education new hires at Step D on the salary schedule to assist with recruitment and retention efforts. Rivera stated in addition to the advanced placement of new candidates, all existing employees in this classification will be advanced to Step D on the salary schedule if they are not already at that step. These changes will be effective January 1, 2025.
  - Rivera reported that at last week's board meeting, the board approved an agreement with Public Agency Retirement Services (PARS) to offer a retirement incentive to eligible non-management employees. She mentioned that the incentive will offer eligible employees a tax-qualified annuity that is equal to 50% of their final year of salary, paid out according to the options selected by the employee. Rivera stated to receive the incentive, eligible employees would have to agree to resign from the district, effective at the end of the current school year.
